Post - Results Services (PRS) Deadlines, fees and charges - Summer 2023

Clerical Check - The script is not re-marked but is checked to ensure that all parts have been marked and that marks have been totalled correctly.

- 1. Clerical check with photocopy of script As above plus a copy of your script.
- 2. Review of marking This is a post-results review of the original marking to ensure that the agreed mark scheme has been applied correctly.
- 3. Review of marking with photocopy of script As above plus a copy of your script.
- **4. Priority Review of marking –** This service is for a student who's University or other higher education places depend on the outcome. This is a priority post-results review of the original marking to ensure that the agreed mark scheme has been applied
- 5. Priority Review of marking with photocopy of script As above plus a copy of vour script.
- 6. Access to scripts Please do not ask for the original script back if you are considering a clerical check or re-mark. Once the script has been returned, it can't be checked or re-marked as its security has been compromised. (See Advice 2 below).
- 7. Access to scripts (Priority) You can request a photocopy of your script to help you decide if you want it checked (re-counted) or re-marked.
